NEUTHOX® 500 Surface disinfection



STEP 1

Remove visible dirt and clean the surface.



STEP 2

Apply NEUTHOX® to the surface with a clean cloth or spray directly onto the surface using the trigger spray. Make sure the surface is evenly covered with NEUTHOX®. NEUTHOX® can also be applied using electrostatic sprayers or cold mist atomizers.



STEP 3

When NEUTHOX® is applied correctly, surfaces are ready for use after just 60 seconds. Drying time depends on the method of application.

Premises/facilities can be used immediately after disinfection.

STEP 1

Spray or press 2-3 ml of NEUTHOX® onto hands.



STEP 2

Massage thoroughly until hands feel dry.

Do not rinse with water.

Surfaces treated with NEUTHOX® do not have to be rinsed after disinfection, even if they come into direct contact with food.
Please note: NEUTHOX® is a disinfectant and does not degrease surfaces.

NEUTHOX® can cause corrosion following prolonged contact with brass, copper, iron, aluminum or steel. Bleaching can occur on certain fabrics.
For use on electronic components such as PCs, monitors and keyboards, apply NEUTHOX® on a cloth and wipe the components. Spray methods are not recommended in these cases.

Product information:

NEUTHOX® is a disinfectant that can be used as a hand (PT1) and surface disinfectant (PT2).

NEUTHOX® PT1 has received approval from the Danish Environmental Protection Agency:

Approval number BPR-reg.nr. 988-1.

This means that NEUTHOX® is legal to market in Denmark.

Work is also underway on an EU application. Once complete, NEUTHOX®

will receive its final approval as a hand sanitizer after Biocides

Regulation - without exemption.

This approval is expected by late 2021.

According to the European Chemicals Agency (ECHA), a hand sanitizer product must have passed at least one of the following tests:

EN 13727 against bacteria

EN 1500 against bacteria

EN 16624 against yeast

NEUTHOX® has passed all these efficacy studies.

NEUTHOX® has also passed the virus effect test EN 14476 and can claim full effect against viruses, including all groups of enveloped viruses such as Coronavirus SARS-Cov-2.

NEUTHOX® PT2 is approved by the Danish Environmental Protection Agency for use in food companies and surfaces that come into contact with food:
